<p>EDUCATION TRUST An Education Trust allows you to set aside funds for education or university funding. Assets and any growth on the funds are outside of the estate. <p>LOAN TRUSTS (to grow assets but outside of your estate) Designed to place assets into a trust structure so that the growth is outside of the estate (and within the trust's protection). You still have access to the original amount invested, by virtue of you having 'loaned' the value to the Trust. You can undertake further IHT planning by 'waiving' segments of the loan repayments so that further sums are within the Trust's ownership and outside of your estate.</p>	£950+vat per person*
